Dear Parents/Guardians,

Belmont Primary School is looking forward to another great year of teaching and learning and would like to advise you of Belmont Primary School's voluntary financial contributions for 2024.

Schools provide students with free instruction to fulfil the standard Victorian curriculum and we want to assure you that all contributions are voluntary. Nevertheless, the ongoing support of our families ensures that our school can offer the best possible education and support for our students. We want to thank you for all your support, whether that's through fundraising or volunteering your time. This has made a huge difference to our school and the programs we can offer.

Within our school this support has allowed us to provide an enriched teaching and learning program for every student that is highly valued by our school community. The commitment and high-level support of voluntary contributions from parents benefits our students and community and results in improved achievement outcomes, wellbeing and engagement in learning. The support of our community through the voluntary contributions allows us to ensure every student has access to the same classroom supplies and learning materials throughout the year and that our school has been able to provide enriched learning opportunities through programs such as Literacy Intervention, robotics in STEM and supporting every student to access the Years 3-6 *Bring Your Own Device Program*. The continued development of the buildings, grounds and varied play spaces has also been possible due to the tremendous support we receive from the community in making the contributions for student owned learning materials and requisites.

At Belmont Primary School, we design and develop teaching and learning programs that continue to draw upon best educational knowledge and practice and our teachers strive to offer broad and enriched programs to students that are above and beyond what is in the standard curriculum and what is provided for by Government funding.

Educational Items for students to own

Attached is a list of items that the school will purchase on your behalf for your child to individually own and use to learn the standard curriculum. These packs will be directly delivered to school prior to the commencement of the 2024 school year. Belmont Primary School makes every effort to keep the cost of items and activities to a minimum and affordable for all parents.

Financial Support for Families

Belmont Primary School understands that some families may experience financial difficulty and offers a range of support options, including:

- Camps, Sports and Excursions Fund (CSEF) provides payments to eligible students to attend camps, sports and excursions. Families holding a valid means-tested concession card or temporary foster parents are eligible to apply and a special consideration category also exists.
- Payment plan options for extra-curricular items and activities such as camps, swimming program and excursions/incursions.
- State Schools Relief may cover the cost of new school uniforms, shoes, books and more for eligible families. Parents or Carers who require assistance are encouraged to make an appointment with the school to discuss their situation.
- Belmont PS Pay It Forward Fund – for families experiencing extenuating circumstances or hardship, voluntary contributions made by the community allow the school to support families who need assistance with the cost of camps, excursions, incursions or swimming. This is managed by the Principal.

Payment methods

Parents will be able to make payments through the Compass Pay system on the Compass App (desktop or mobile device).

We ask that parents aim to make all voluntary contributions and payments by Friday 23rd February 2024, however the school will continue to accept voluntary contribution payments throughout the school year.

Refunds

Parent requests for refunds are subject to the discretion of the school and made on a case-by-case basis. Refunds will be provided where the school deems it is reasonable and fair to do so, taking into consideration whether a cost has been incurred, the Department's Parent Payment Policy and Guidance, Financial Help for Families Policy and any other relevant information. The school will always work with parents who request a refund where circumstances or arrangements have changed and consider each request carefully and fairly on an individual case-by-case basis.

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
